AUTHORITY TO ACCEPT SERVICE OF A SUBPOENA. 2. MR. BEST ALSO ALSO INFORMED EVAN T. DARR OF THE OCTOBER SURPRISE INVESTIGATION OF MY WILLINGNESS TO COOPERATE WITH THE COMMITTEE "SOMETIME IN THE EARLY FALL."

I HAVE NO CONCRETE PLANS TO RETURN TO THE U.S. AT THIS POINT,

BUT SEPTEMBER WOULD APPEAR TO BE A LOGICAL TIME TO DO SO. IF THE OCTOBER SURPRISE INVESTIGATION CONTACTS THE DEPARTMENT, I REQUEST THAT YOU TELL THEM OF MY INTENTION TO COOPERATE FULLY WHEN I RETURN TO THE STATES, PROBABLY IN SEPTEMBER. ANY OTHER INQUIRIES SHOULD BE REFERRED TO MY LAWYER, JUDAH BEST.
