

79. Having read the United Nations Convention Definition of a Refugee, please provide a comprehensive statement of your reasons for your claim for refugee status in Australia.

Your statement may be written in any way you wish and may be of such length as you consider necessary. It should, however, address the following points:

- what were the reasons for which you left your home country
- why do you consider you cannot return to it
- what do you think would happen to you personally if you were to return
- what would happen to your family members if you were to return
- do you have any documentary evidence to support your claim for refugee status (if Yes, attach documents)

MY CASE IS AN UNPRECEDENTED CASE OF POLITICAL PERSECUTION BY TWO GOVERNMENTS. IT WAS AN ATTEMPT BY ISRAEL AND THE UNITED STATES TO COVER-UP THEIR RELATIONS WITH IRAN SINCE 1979. WHILE ON A PRIVATE VISIT TO THE U.S., WITHOUT A DIPLOMATIC PASSPORT, I WAS FRAMED AND ACCUSED OF ILLEGALLY SELLING ARMS TO IRAN. POSSIBLY THIS WAS A CONTINUATION OF THE EARLIER PROSECUTION OF OTHER INDIVIDUALS ON SIMILAR CHARGES. I WAS NOT WILLING TO KEEP QUIET AND BE DISCREDITED BY PLEADING GUILTY TO THE BOGUS CHARGES. I DID NOT ACCEPT MY GOVERNMENT'S PROPAGANDA TO DO ANY ARMS SALES TO IRAN THAT I WAS INVOLVED IN WAS SOLELY IN THE CAPACITY OF BEING AN EMPLOYEE OF THE ISRAELI GOVERNMENT. EVERYTHING I DID WAS AUTHORIZED BY THE APPROPRIATE AUTHORITIES IN THE ISRAELI AND UNITED STATES GOVERNMENTS. SINCE I DID NOT GO ALONG WITH THE PROGRAM AND I DECIDED THAT I WOULD TRUTHFULLY DEFEND MYSELF IN COURT, I WAS DISOWNED BY THE ISRAELI GOVERNMENT AND WILL BE PROSECUTED FOR BREAKING THE OFFICIAL SECRETS ACT IF I RETURN TO ISRAEL. AS AN AFTERMATH OF MY TRIAL, A NEW SCANDAL HAS BROKEN IN THE UNITED STATES, DIRECTLY INVOLVING THE PRESIDENT OF THE UNITED STATES. THE BEST PROOF OF MY INNOCENCE IS THE FACT THAT AFTER I WAS HELD WITHOUT BAIL FOR 11 MONTHS AND 3 WEEKS, I RECEIVED AN UNPRECEDENTED ACQUITTAL. EVEN THOUGH I WAS ACQUITTED, I WAS RENDERED STATELESS AND IN A LIFE THREATENING SITUATION. MY CASE AND MYSELF HAS RECEIVED A LOT OF U.S. AND INTERNATIONAL ^{MEDIA} ATTENTION INCLUDING AUSTRALIAN NEWSPAPERS, TELEVISION AND RADIO. IF I RETURN TO ISRAEL, I WILL BE PROSECUTED FOR THE OFFICIAL SECRETS ACT VIOLATIONS, BEHIND CLOSED DOORS "FOR NATIONAL SECURITY REASONS", AND I WILL NEVER AGAIN SEE THE LIGHT OF DAY. PARADOXICALLY SPEAKING,
